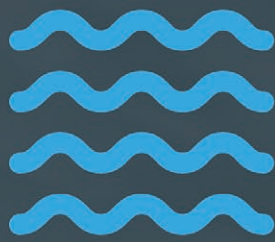

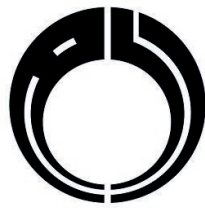

# LETTER OF WELCOME

Dear Symposium Delegates,

It has been a long and challenging winter for many of us who have continued to be distanced from each other because of the ongoing pandemic. However, through a combination of science, innovation and education, there is a lot to give grounds for optimism. We must ensure that the lessons we are learning now encourage us to build back better, and in a way that is more responsible and responsive, and that allows for international cooperation and collaboration to be strengthened.

One of the first major outbreaks of COVID-19 outside Wuhan, China was on the Diamond Princess cruise ship, which had visited Hong Kong, and was allowed to dock in Yokohama, where it was quarantined. Japan found itself at the center of huge media attention as the ship became an unwitting public health case study of the spread of the coronavirus in confined spaces, and one of diplomacy, international law and public policy in Japan's response, and as cruise ships around the world found themselves being turned away from ports.

Last year, IAFOR was commissioned by the Japanese Ministry of Foreign Affairs to undertake a major interdisciplinary research project on the outbreak of infectious diseases on cruise ships, and which is ongoing. Coordinated through the IAFOR Research Centre at the Osaka School of International Public Policy (OSIPP) at Osaka University, the research brings together Japanese and international experts working in the fields of international and maritime law, international relations, public health and the built environment, and involves the cooperation of University College London, the East-West Center (Washington DC), Clingendael - the Netherlands Institute of International Relations, and the National University of Singapore. I would like to thank the many individuals and institutions involved in bringing this research project together, and especially Professor Haruko Satoh, who coordinated the research team.

This symposium will discuss the findings of the research project in an event held in hybrid form in Tokyo, and online, and will be attended by government officials, policy-makers, academics scholars, media representatives, and all those with an interest in this ongoing issue.

This will be the first event that we will have been able to hold onsite since the onset of the pandemic, although the audience will be limited to those in Japan as the country is still closed, but will allow us to operate the hybrid model that we have innovated in preparation for events restarting. We are hopeful that by the autumn we will be able to travel more easily, see each other again, and breathe new life into our International Academic Forum.

##### BY RAIL

1. From Narita Airport (all terminals) take the Narita Express to Tokyo Station.
2. Transfer to the JR Yamanote Line (Clockwise towards Shinagawa) from Tokyo Station and get off at the next stop, Yurakucho Station (JY30).
3. From Yurakucho Station transfer to the Tokyo Metro Yurakucho Line (Y18).
4. Get off at Nagatacho Station (Y16).
5. Exit the station at exit 9b and cross the street. Follow the walkway straight for about 100 meters. The Toshi Center will be on your right, and there are signs in both Japanese and English.

##### BY AIRPORT LIMOUSINE BUS

From Narita Airport take the airport limousine bus to Tokyo Garden Terrace Kioicho. Tokyo Garden Terrace Kioicho is located across the street from the Toshi Center Hotel.

#### FROM HANEDA AIRPORT

##### BY RAIL

1. Take Tokyo Monorail at Haneda Airport Station for Hamamatsucho Station
2. Transfer to the JR Yamanote Line at Hamamatsucho Station to Yurakucho Station
3. From Yurakucho Station transfer to the Tokyo Metro Yurakucho Line (Y18).
4. Get off at Nagatacho Station (Y16).
5. Exit the station at exit 9b and cross the street. Follow the walkway straight for about 100 meters. The Toshi Center will be on your right, and there are signs in both Japanese and English.

##### BY AIRPORT LIMOUSINE BUS

From Haneda Airport take the airport limousine bus to Tokyo Garden Terrace Kioicho. Tokyo Garden Terrace Kioicho is located across the street from the Toshi Center Hotel.

#### FROM WITHIN TOKYO

Take the Tokyo Metro to Nagatacho Station. Nagatacho Station (Y16, Z04, N07) is served by the Hanzomon Line (Z), Yurakucho Line (Y), and Namboku Line (N).

Exit the station at exit 9b and cross the street. Follow the road straight for about 100 meters, walking past the Junior High School. The Toshi Center will be on your right, and there are signs in both Japanese and English. Family Mart is on the left.



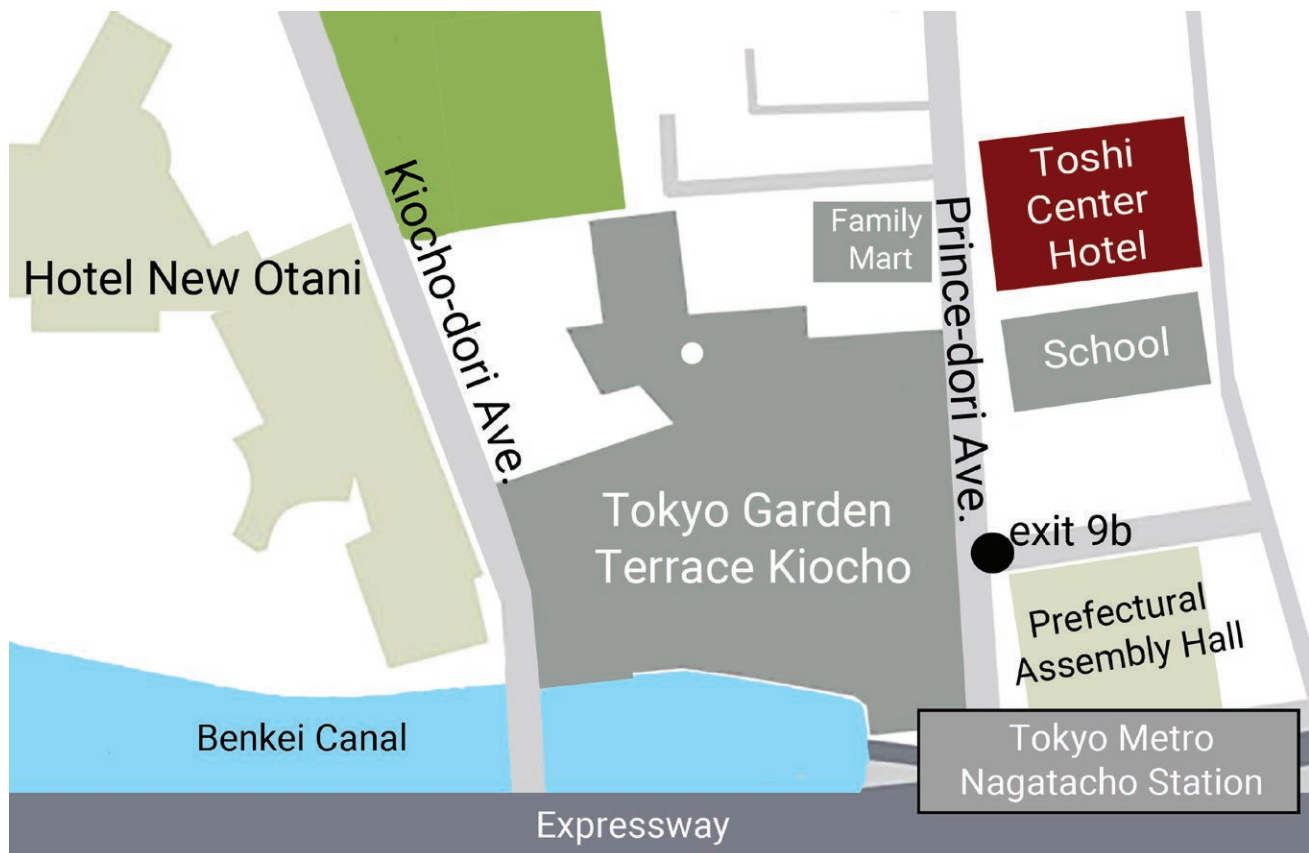

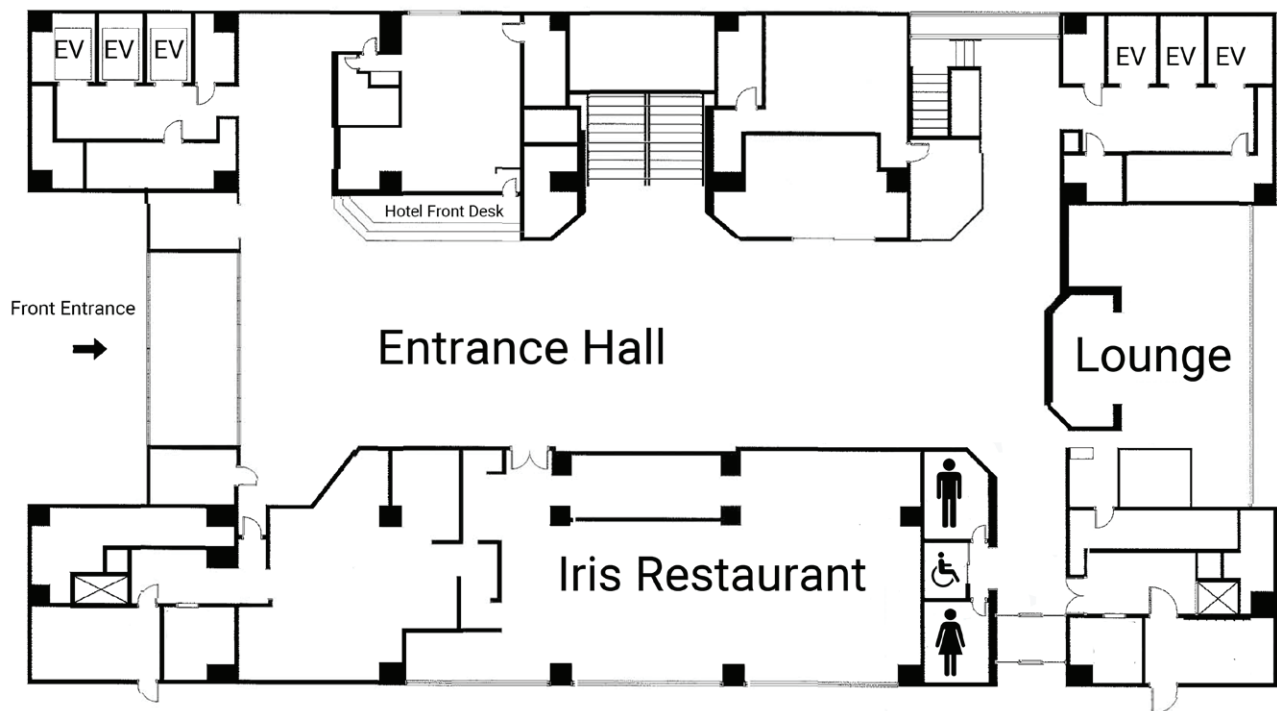

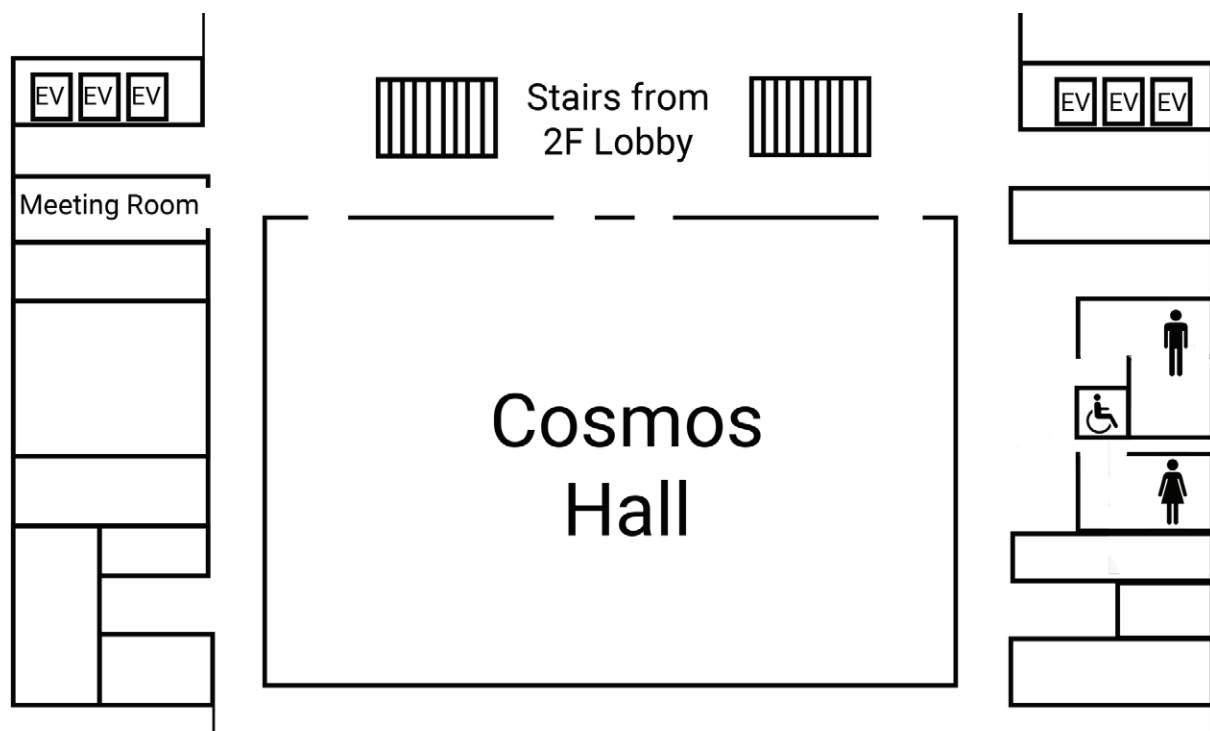

# HOTEL COVID-19 POLICY

## PUBLIC SPACES

### 1. Monitoring the health of hotel guests

At check-in, guests are asked about their general health, body temperature and whether they are required to self-isolate after recently returning from overseas, as well as other health-related questions as appropriate.

### 2. Masks for staff

For the health and safety of guests, all staff are required to wear masks.

### 3. Cleaning and disinfection

Guest rooms and shuttle buses as well as high-touch surfaces such as door handles, sliding doors and elevator buttons are regularly wiped down and disinfected with alcohol disinfectant.

### 4. Hand sanitizer

Alcohol-based hand sanitizer is available to guests at multiple points throughout our hotels including lobbies, restaurants and bars.

### 5. Ventilation of our facilities

The areas of this hotel used by our guests are continuously ventilated with replenished cycles of fresh air from outside through our airconditioning system.

## GUEST PROTOCOLS

1. We respectfully ask that you refrain from using our facilities if you have a high temperature or are feeling unwell.

2. If you begin to feel unwell at any time during your stay, please inform a member of staff immediately.

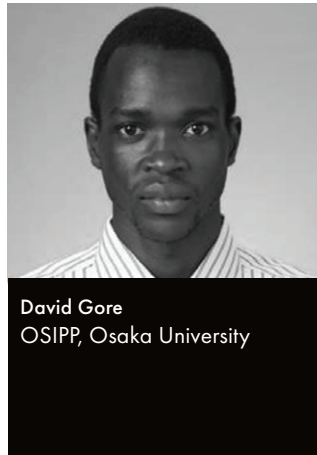

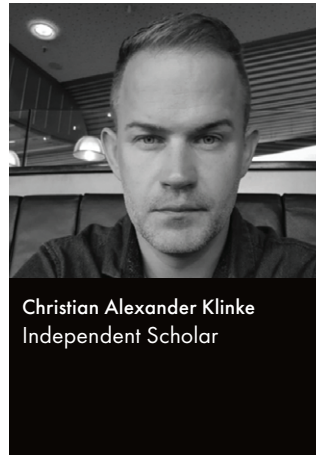

## BIOGRAPHY

Joseph Haldane is the Chairman and CEO of IAFOR. He is responsible for devising strategy, setting policies, forging institutional partnerships, implementing projects, and overseeing the organisation's business and academic operations, including research, publications and events.

Dr Haldane holds a PhD from the University of London in 19th-century French Studies, and has had full-time faculty positions at the University of Paris XII Paris-Est Créteil (France), Sciences Po Paris (France), and Nagoya University of Commerce and Business (Japan), as well as visiting positions at the French Press Institute in the University of Paris II Panthéon-Assas (France), The School of Journalism at Sciences Po Paris (France), and the School of Journalism at Moscow State University (Russia).

Dr Haldane's current research concentrates on post-war and contemporary politics and international affairs, and since 2015 he has been a Guest Professor at The Osaka School of International Public Policy (OSIPP) at Osaka University, where he teaches on the postgraduate Global Governance Course, and Co-Director of the OSIPP-IAFOR Research Centre, an interdisciplinary think tank situated within Osaka University.

He is also a Visiting Professor in the Faculty of Philology at the University of Belgrade, a Member of the International Advisory Council of the Department of Educational Foundations at the College of Education of the University of Hawaii at Manoa, and a Member of the World Economic Forum's Expert Network for Global Governance.

From 2012 to 2014, Dr Haldane served as Treasurer of the American Chamber of Commerce in Japan (Chubu Region) and he is currently a Trustee of the HOPE International Development Agency (Japan). He was elected a Fellow of the Royal Asiatic Society in 2012, and a Fellow of the Royal Society of Arts in 2015.

## 略歴

ジョセフ・ハルデイン（博士）は、現在IAFORの会長兼CEO。戦略の策定、方針の設定、組織的パートナーシップの確立、プロジェクトの実施、そして研究、出版物およびイベントを含む組織の事業および学術業務の監督を担当。

ハルデイン博士は、19世紀フランス研究においてロンドン大学にて博士号を取得。パリ第12大学（パリ・エスト・クレティユ大学）（フランス）、パリ政治学院（フランス）、名古屋商科大学（日本）で常勤教員のポジション、パリ第2大学（パントオン・アサス大学）IFP（French Press Institute）（フランス）、パリ政治学院ジャーナリズム学部（フランス）、モスクワ大学ジャーナリズム学部（ロシア）の客員教員のポジションを務めた。

現在の研究は、戦後と現代の政治と国際情勢に焦点を当てており、2015年以来、大阪大学大学院国際公共政策研究科（OSIPP）の招へい教授を務める。そこでは、大学院グローバルガバナンスコースを教え、大阪大学内にある学際的シンクタンクであるOSIPP-IAFOR研究センターの共同ディレクターを務める。

また、ベオグラード大学哲学学部の客員教授、ハワイ大学マノア校エジュケーションカレッジの教育基礎学部の国際諮問会議のメンバー、グローバルガバナンスに取り組む世界経済フォーラムのExpert Networkのメンバー。

2012年から2014年にかけて、在日米国商工会議所（中部地域）の会計役を務め、現在、ホープ・インターナショナル開発機構（日本）の評議員に就任。2012年に王立アジア協会のフェロー、2015年にロイヤル・ソサエティ・オブ・アーツの研究員に選ばれる。

She is also co-director of the OSIPP-IAFOR Research Centre and she was previously part of the MEXT Reinventing Japan project on "Peace and Human Security in Asia (PAHSA)" with six Southeast Asian and four Japanese universities.

In the past she has worked at the Japan Institute of International Affairs (JIIA), Chatham House, and Gaiko Forum. Her interests are primarily in state theory, Japanese nationalism and identity politics.

Professor Haruko Satoh is a member of IAFOR's Academic Governing Board. She is Chair of the Politics, Law & International Relations section of the International Academic Advisory Board.
